6. Chiefs Summary and Report

- **a.** Year to date we have had 286 requests for service, last year we had 274: making for 12 more this year.
- **b.** There have been 30 requests for services since last Board Meeting on 8/18/2022.

- c. Significant calls:
- 1. 8/26 MVA I-40, MP 185 Offramp two vehicle MVA, 1 patient transported.
- 2. 8/28 MVA I-40, MP 181 E Semi in the ditch, non-injury.
- 3. 9/3 MVA I-40, MP 171 UTV rollover, 1 patient transported.

7. Old Business

- a. Discussion regarding Loven Contracting Chairman moved this agenda item to immediately follow financials.
 - Mike Loven presented to the Board in regard to the "re-opening fee" and what that entails. Mr. Loven will be available if any additional questions come up in the future.

Administrative Update

- a. We have had zero new subscriptions since 8/18/2022
- **b.** Since 8/18/22 we have billed for seven out of district calls totaling \$4,221.37.
- c. FY to date we have billed a total of ten out of district calls totaling \$6,576.37.
- d. The wildland revenue for this fiscal year is currently \$50,155.74. The total "profit" from that after all the costs are paid is currently \$16,230.45. The billing information has been submitted by the crew, reimbursement for the Severity Fire is currently being worked on..
- e. We have made a total of \$57,297.80 in deposits. One of those deposits being \$55,534.22 from EFT credit (State of AZ). (Wildland reimbursement)

9. New Business

- **f.** Discussion and possible action regarding PSPRS employee reimbursement.
 - Ponderosa Fire District was notified through a webinar at the end of August 2022 that PSPRS had made an error in both some former and current PFD employee contributions The amount in which PSPRS stated is owed to the employees, is \$87,861.06. Under Statute, PSPRS cannot pay our employees directly because of this statute, PSPRS has requested that PFD pay the amount owed to the employees by 9/30/2022. As this was not a budgeted expense, the district is working with the Coconino County Deputy County Attorney and Treasurer to determine all options to address the issue. We plan to have another meeting with PSPRS in the coming weeks. As we get more information and things progress, we may ask for a special Board meeting before the end of the month.
